- The Earnest Money shall be accepted in the form of Deposit at Call Receipt of a Scheduled Nationalized Bank/Fixed deposit receipt of a scheduled Nationalized Bank/Demand Draft of a Scheduled nationalized Bank guaranteed by the Reserve Bank of India issued in favour of the Block Development Officer Gangte Kra Daadi District, Arunachal Pradesh separably which should accompany with the Tender documents.

  - Produce Work Experience Certificate having satisfactorily completed similar nature of works for last three years.
