

- 14. No Engineer of Gazetted rank or other Gazetted Officer employed in an Engineering Department of the Government of Arunachal Pradesh is allowed to work as a contractor for a period of two years after his retirement from service, without the prior permission of the Government of Arunachal Pradesh in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of Arunachal Pradesh as aforesaid before submission of the tender or engagement in the contractor's service.
